SUCCESS STORY #1

EUROFRONT



PROJECT TO STRENGTHEN INTEGRATED BORDER MANAGEMENT IN SOUTH AMERICA

SERVICE: Conducting an official curriculum audit, consultancy, and diagnostic report; creation of curriculum frameworks and content; as well as training for 14 institutions across 9 South American countries (Argentina, Bolivia, Brazil, Colombia, Ecuador, Peru, Paraguay, Chile, and Uruguay).

CLIENT NAME: EUROFRONT (FIAPP) and beneficiary countries.

EXISTING NEEDS: To enhance the Integrated Border Management capabilities of national police forces and migration agencies.

OUTCOME:

- Completion of 18 audits (one for each institution) in the 9 beneficiary countries, assessing their official curricula.
- Delivery of 18 diagnostic reports with recommendations to improve the official curricula of each institution and beneficiary country.
- Design, delivery, and facilitation of training content with the participation of 8 active national police officers and civil guards, covering:
 - Introduction to Integrated Border Management
 - International Legislation on Migration and Borders
 - International Cooperation for Border Management
 - Human Rights and Cultural Diversity at Borders
 - Management and Control of Migratory Flows
 - Management and control of goods and vehicles at borders.
 - Detection and analysis of fraud and document forgery.
 - Detection, prevention, and investigation of cross-border crime.
 - Identification and analysis of risks and threats at borders.
 - Collection and analysis of border intelligence.

SUCCESS STORY #2



NATO - NORTH ATLANTIC TREATY ORGANIZATION

SERVICE: Tailor-made consultancy to develop a best practices manual on how to carry out assessments of the future strategic environment, defining the best techniques and methodologies for NATO member countries to unify criteria and homogenize the Strategic and Prospective Analysis in their respective countries, anticipating risks, threats and opportunities at the strategic level.

CLIENT NAME: STO **NATO** (North Atlantic Treaty Organization).

EXISTING NEED: Since 2014, the strategic security environment has changed dramatically due to the rapid pace of technological advances and political, economic, social and environmental developments, which have increased complexity and uncertainty.

NATO's strategic assumptions have also changed, and will continue to be challenged:

- The complexity and rapid pace of change requires a thorough understanding of the future strategic environment, one of the main drivers of Alliance adaptation, to ensure that NATO's military capabilities, and especially its command structure.
- Efforts exist to anticipate and develop an understanding of the future security environment, such as the Strategic Foresight Analysis and the Framework for Future Operations. However, there is no unified code that can be used by NATO and nations.

CONTEXT: Appointment by the Secretary of State for Defense (Ministry of Defense, Spain) in the working group SAS-154 "Future Strategic Environment Assessment: Framework for Analysis" of the SAS Panel "System Analysis and Studies Panel" in the NATO Science & Technology Organization (STO - Science & Technology Organization | NATO - North Atlantic Treaty Organization).

SUCCESS STORY #3

PERU'S NATIONAL POLICE - INTELLIGENCE DIVISION

SERVICE: Tailor-made, online, asynchronous training program with +150 live classes on **Intelligence Analysis and Criminal Analysis**.

CLIENT NAME: Intelligence Division of the **Peruvian National Police**, through the Inter-American Development Bank. **540 people trained**.

REQUIREMENTS: The Peruvian National Police, as a result of the evolution of organized crime and existing threats, needed to improve the knowledge and skills of its Intelligence Division agents.

OUTCOME: A series of training actions were defined, achieving the following objectives:

- Five Diplomas were designed in less than 30 days, namely:
 - **Diploma in Criminal Analysis, Diploma in Special Intelligence Operations, Diploma in Tactical Analysis in Intelligence Operations, Diploma in Statistical Methods Applied to Intelligence and Diploma in Capture and Management of Human Sources**, composed of 11 training groups on different days and schedules.
- The modality had to be asynchronous (Virtual Campus), as well as synchronous through live videoconferences with more than 40 Professors, all of them active professionals (Police, Military, and members of Intelligence Agencies from 12 different countries).
- 96% of the trained and certified workers were "Very satisfied" with the training received, confirming that they would recommend it to other colleagues in their organization.
- The Peruvian National Police managed to train all the agents of its Intelligence Division in record time, in a personalized way and adapted to the needs they had identified and fulfilling the requirements to finance it through the Inter-American Development Bank (IDB).

SUCCESS STORY #4



PANAMA GOVERNMENT & UNITED NATIONS

SERVICE: Tailor-made blended learning program in **International Analysis and Geopolitical Reporting**.

CLIENT NAME: Ministry of Foreign Affairs of Panama, through the **United Nations (UN)**. **120 people trained.**

REQUIREMENTS: The Ministry of Foreign Affairs of Panama, hand-in-hand with the United Nations, in line with its strategy of constant improvement of its International Analysts and officials of the Diplomatic and Consular Career, presented a public competition-tender to be able to improve, evaluate and certify their knowledge and skills in International Analysis and Geopolitics.

OUTCOME: Once the learning objectives were validated, the customized training program was structured to be delivered in blended learning: 80 hours in online mode and 20 hours in face-to-face mode, with the professors traveling to Panama. For the institution, the updating of human resources has been fundamental for the development of foreign policy strategies, specifically:

- The **Panama Mission Plan**, focused on the rescue and promotion of the country's image worldwide.
- The **ProPanama Agency** for the attraction of investments and the search for markets for Panamanian exports, for a sustainable economic and social development.

The Secretary General of the Ministry, indicated that this training and professional certification has raised the profile of the Ministry of Foreign Affairs, as a driver executor of a unique, coherent and consistent foreign policy.

SUCCESS STORY #5



METRO DE BARCELONA & SECURITAS

SERVICE: Tailor-made, online & asynchronous training program on a Critical Infrastructure Security (Barcelona Subway).

CLIENT NAME: Securitas & Metro de Barcelona. **1,700 people trained.**

REQUIREMENTS: Securitas, aware of the increase and variability of risks and threats to which Critical Infrastructures are exposed, as well as the evolution of public and private security regulations, proactively proposed to its client, Metro de Barcelona (*Barcelona's Subway Company*), the design of a totally customized training for all of Securitas security personnel working in its facilities.

OUTCOME: The following objectives were achieved through this training action:

- Innovation in the training received by security personnel (fully online and personalized), in coordination with Spain's central **Ministry of Internal Affairs** and the *Department d'Interior of the Catalan Generalitat*, exceeding the standards of current regulations.
- Private security personnel serving in this Critical (and strategic) infrastructure, will now have advanced knowledge & skills, and this will be easily evaluated and measured in a scalable and reliable way.
- Trained workers were trained in those Operational and Security Culture key topics requested by their client, Metro de Barcelona.
- The vast majority of trained workers passed the evaluation and obtained their professional qualification (issued by LISA Institute), which enabled them to work in Metro de Barcelona.
- 92% of trained workers were "*Very satisfied*" with the training received, confirming they would recommend it to other colleagues.
- Securitas was able to contribute a greater value to its client, Metro de Barcelona, by continuously improving its security services, becoming a strategic security partner in the long-term for its client.

SUCCESS STORY #7



DELOITTE

SERVICE: On-site training program in **Cybersecurity**.

CLIENT NAME: Deloitte Spain. **500 people trained.**

REQUIREMENTS: The tech division at Deloitte informed us the need to train a team of people in Cybersecurity, evaluating and certifying *a posteriori* the knowledge and skills acquired. This Deloitte team was going to take on a technological project for another company that required them to have training in Cybersecurity Fundamentals in order to comply with the implemented Security Policy.

OUTCOME: After receiving the request, LISA Institute, **in less than 3 weeks**, designed and prepared a tailor-made training action, which achieved the following objectives:

- Trained workers understood best practices in Cybersecurity, identifying most common risks and threats, thus increasing their resilience.
- 100% of attendees passed the evaluation and obtained the professional certification they needed to be able to carry out the project.

METRO DE BARCELONA & TRANSPORTS METROPOLITANS DE BARCELONA

SERVICE: Customized training program on Detection and Prevention of Bank Fraud and Scams.

CLIENT NAME: Barcelona Transports and Barcelona Metro. **42 people trained.**

REQUIREMENTS: *Transports Metropolitans of Barcelona*, as a result of the cyber threats to which they were exposed as public company in the daily management of suppliers, billing, and payments. They requested customized training, in person and interactive, to train your workers in the detection and management of any possible risk of scam, phishing, or fraud banking.

OUTCOME: Through this training action, it was achieved that all workers:

- They would know the *modus operandi* that cybercriminals use the most to commit bank fraud and scams.
- Learn to identify the common indicators of bank fraud or scam.
- Know the most effective preventive measures to avoid or mitigate the possibility of being a victim of banking fraud or scam.
- Learn the most recommended action protocols in each case.

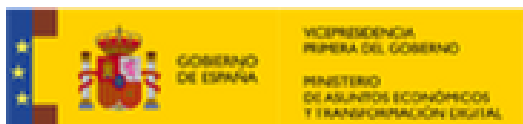
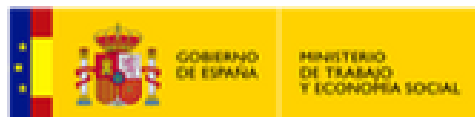
