# **Roadmapping Workshop**

## Aim

This workshop aims to identify policy actions to seize the opportunities and mitigate the challenges of demographic change for Europe's R&I system.

### Flow

Participants will be divided into four subgroups, each focusing on one of the predefined dimensions of demographic change for Europe's R&I ecosystem:

- The effects on (tertiary) education systems,
- Interactions between the R&I ecosystem and related markets,
- Impact on R&I funding,
- Socio-spatial implications.

Within their assigned dimension, the subgroups will brainstorm and propose policy actions related to challenges and opportunities identified through the previous steps of the project.

The workshop will include:

- Introduction to the challenges and opportunities along with the roadmapping template,
- a session dedicated to identifying key policy actions,
- a session for highlighting key findings from the group work.

The key activities during this workshop should encompass proposing new policies, public campaigns, research, and other initiatives. It's also crucial to identify key stakeholders and the resources needed to implement these activities. Additionally, discussions should cover essential educational needs for shifting societal and public perceptions, as well as job market considerations, including how employers can both find talent and foster innovation through new roles and solutions.
